**I understand that ACC does not tolerate drunkenness, the appearance of drunkenness, loud arguing, threats or violence of any kind, or loud noises during quiet hours, or harassing or disturbing other campers. If, in the opinion of the staff, I am engaged in any of this, or anyone with me is engaged in any of this, all associated persons will be required to leave the campground immediately without a refund.**

All sites are presumed free of damage, broken glass, or other serious issues. **If this is not the case, I must notify staff in writing within 4 hours of my arrival.** Sites with significant cleanliness or damage issues will be subject to a service fee of \$50.00 or actual damages, whichever is greater.

This Liability Waiver and Indemnity is binding on me, my heirs, agents, personal representatives, successors, assigns, and other persons acting or purporting to act on my behalf. My estate or I will reimburse Abrams Creek Center, Inc. and/or any or all of the named parties associated with Abrams Creek Center, Inc., for any and all costs and attorneys' fees in defending any lawsuits or claims filed by me or on my behalf.
